### **RESOLUTIONS**

RES. # 22-19 A Resolution authorizing the approval of the minutes of the remote Meeting of the Troy Housing Authority Board of Commissioners held on Wednesday, August 17, 2022.

Minutes will be reviewed by board members, modified if needed, and then approved by the Board.

RES. # 22-20 A Resolution approving the Troy Housing Authority 2023 Agency Plan, The 2022 Capital Fund Plan, The On-Going 2022-2026 Capital Fund 5-Year Plan, and authorizing the submission of these plans to HUD.

RES. #22-21 A Resolution approving an updated Family Self Sufficiency (FSS) Program Action Plan. The FSS Action Plan has been updated to include new requirements issued by HUD Notice issued June 16, 2022 entitled Streamlining and Implementation of Economic Growth, Regulatory Relief, and Consumer Protection Act Changes to Family Self-Sufficiency (FSS) Program. Board approval is needed to submit the updated FSS Action Plan to HUD.

**RES.#22-22 Resolution to approve the financial closing of Taylor 1 Apartments.** The resolution approves all of the actions that will be taken at the financial closing of Taylor 1 Apartments. These actions are based on the initial Term Sheet with Pennrose and have been vetted through our Legal Counsel at Reno & Cavanaugh.

**RES. #22-23 A Resolution approving updates to the Section 8 Administrative Plan.** Updates to the Section 8 Administrative Plan are being proposed for review and approval by the Board. The updates consist of clarification of the Income Limits for RAD properties, setting an annual cap of 15% on transfers from RAD properties to the Tenant Based Voucher program, and describing the elements of a new RAD property (Taylor I).
