A RESOLUTION APPROVING THE SELECTION OF CONTRACTORS TO MODIFY APARTMENTS AT GRISWOLD HEIGHTS TO COMPLY WITH UNIFORM FEDERAL ACCESSIBILITY STANDARDS (UFAS).

WHEREAS, on August 19, 2020 the Troy Housing Authority released an Invitation For Bids (IFB) developed in collaboration with Sandra Dardinelli an Architect with Bernier, Carr & Associates, PC (BCA) for Uniform Federal Accessibility Standards improvements to apartments; and

WHEREAS, the IFB called for submissions from three trades: General Construction Work, Mechanical (HVAC) Work and Electrical Work and requested a Base Bid for 4 apartments at Griswold Heights and potential alterations (adding UFAS improvements to an apartment at Corliss Park, adding work on Building 1 at Corliss Park, deducting an apartment at Griswold Heights) as well as unit costs for Constructing Exterior Ramps and removal of Vinyl Asbestos Tile (VAT); and

WHEREAS, submissions were received on September 22, 2020 and reviewed by Troy Housing Authority (THA) staff in collaboration with staff from BCA; and

WHEREAS, based upon staff and architectural review the best course of action is to proceed with the Base Bid, without alternates, and award contracts as follows: General Construction Work to Gallo Construction Corp. in the amount of \$384,600.00 with ramp costs at \$31,900.00 per 15 foot run and VAT removal at \$80.00 per square foot, Mechanical (HVAC) Work to T. McElligott, Inc. in the amount of \$137,000.00 and Electrical Work to Harold R. Clune, Inc. in the amount of \$74,000.00; and

WHEREAS, the Facilities Committee has reviewed the staff and architect recommendations and recommends that the full Board of Commissioners approves this course of action.

NOW, THEREFORE, BE IT RESOLVED that the Executive Director is authorized to engage Gallo Construction Corp. T. McElligott, Inc. and Harold R. Clune, Inc. to complete UFAS modifications to 4 apartments at Griswold Heights at the prices noted above and in accordance with the IFB.


