Troy Housing Authority issued a Request for Proposal (RFP) seeking sealed proposals from qualified, licensed, and bonded entities to provide Pest Control Services to the Troy Housing Authority. The THA received two proposals and designated a three-person panel to review and score the responses. THA determined that the current incumbent Alleymore, Inc. DBA Pest Master Services was the recommended vendor based on overall score and price and is recommending to the Board to authorize the Executive Director to enter into a contract with Pest Master.
