Upon Roll Call, seven Commissioners were present. Chair Steele introduced Rick Mason as the new Commissioner, replacing Justin Relf.

Chair Steele moved to Resolution 24-11, the approval of the minutes of the meeting of the Troy Housing Authority held on May 22, 2024. Commissioner Sanders moved to approve the minutes. Commissioner Rodriguez seconded the motion. When put to a vote, the minutes were approved. Commissioner Mason abstained since he was not at the May 22, 2024, meeting.

Chair Steele moved to Resolution 24-12, a resolution authorizing the approval of the Financial Closing of Troy Portfolio Preservation Bundle 2. Commissioner Jackson moved to approve the resolution. Commissioner Howard seconded the motion. When put to a vote, the resolution was adopted unanimously.

Chair Steele moved to Resolution 24-13, a resolution authorizing the approval of amendments to the Development Term Sheet and a HUD Interim Agreement for the John P. Taylor Apartments Buildings 3 & 4. Commissioner Sanders made a motion to bring the resolution forward for discussion. Commissioner Rodriguez seconded the motion. After some discussion, the resolution was adopted unanimously 7/0.

Chair Steele asked if there was any old or new business. Deborah Witkowski stated that she received a request from a few commissioners suggesting that the July regular Board meeting be cancelled. The Board of Commissioner took a vote and unanimously agreed to cancel the July meeting and reschedule a subsequent special meeting should any items for Board review and approval become necessary.

Chair Steele made a motion to adjourn. Commissioner Jackson approved the motion.

Commissioner Sanders seconded the motion. The meeting was adjourned at 4:58.
