RES. # 25-22: A Resolution approving revisions to the Troy Housing Authority By-laws. Revisions to the Bylaws of the Troy Housing Authority are being proposed for review and approval by the Board of Commissioners. As the By-laws had not been updated since Novemebr 2015, at the June 25, 2025 meeting, the Board of Commissioners were given an opportunity to thoroughly review and propose changes to the Chair and Executive Director by August 1, 2025.
